Resolved, that Rick Maedl is appointed to the position of set construction engineer for the 2016 musical at a stipend of \$500.

Mr. Waters moved, seconded by Mr. Bond, upon the recommendation of the Superintendent, that Bill Bruning is appointed to the position of unpaid assistant baseball coach for the 2016 spring sports season.

Mr. Koch moved, seconded by Mr. Bond, upon the recommendation of the Superintendent, to approve the following resolutions:

Resolved, upon the recommendation of the Superintendent, that the donation of books from Randy Schultz with the request that they go to the high school library is gratefully accepted per Board policy #5230.

Mr. Waters moved, seconded by Mrs. Choate, upon the recommendation of the Superintendent, that the legal notice for the annual meeting and board member election to be held on May 17, 2016 is approved as presented.

BOARD ITEMS

- Mr. Koch asked if the Board could have a list of all stipends/costs paid out for the musical from both the District and any outside funding. Discussion: the District does not have access to the records of outside organizations.
- Mr. Waters complimented the students on their good behavior during musical and sports practices.
- Mrs. Fry asked about academic ineligibility for extracurricular activities. Mrs. Murphy will check into it, gather information and report back to the Board.
- Mr. Bragg spoke about the recent budget workshop that was held on March 16. The Board addressed the Corrective Action Plan (CAP) resulting from the recent NYS OSC audit and agreed to use a portion of the retirement reserve, pay off the BAN on the wireless project and present a tax levy with a 0% increase. Discussion: Mr. Koch commented that going out at 0% inhibits the ability to raise revenue.
- Mr. Bragg reported on the preliminary findings from the Niagara County Health Care Consortium feasibility study and stated that the savings to the District would be nominal.

Mr. Waters moved, seconded by Mr. Bond, upon the recommendation of the Superintendent, to rescind the resolution previously adopted at the February 25, 2016 meeting establishing the tax levy limit for the 2016-2017 school year at the legal limit and change it to a tax levy increase of 0%. 6 yes/1 no (Koch)

Motion carried.

Mr. Bond moved, seconded by Mr. Waters, upon the recommendation of the Superintendent, that the Royalton-Hartland Central School District will no longer be a part of the feasibility study with the Niagara Orleans Municipal Cooperative Health Care Consortium.

Motion carried.
