Mr. Koch moved, seconded by Mrs. Hoerner, upon the recommendation of the Superintendent, that Bill Holahan is appointed to the position of varsity volleyball coach for the 2014 fall sports season. Salary stipend of \$4,851.00 is 7% of Step 20 of the current RHTA Agreement. Employment shall be effective through the end of the 2014 fall sports season unless terminated sooner. Motion carried.

Mr. Bragg moved, seconded by Mrs. Hoerner, upon the recommendation of the Superintendent, that Doug Meyer is appointed to the position of JV volleyball coach for the 2014 fall sports season. Salary stipend of \$2,941.00 is 5% of Step 16 of the current RHTA Agreement. Employment shall be effective through the end of the 2014 fall sports season unless terminated sooner. Motion carried.

Mr. Waters moved, seconded by Mr. Koch, upon the recommendation of the Superintendent, that Stacy Boyle is appointed to the position of cheerleading coach for the 2014-2015 sports season. Salary stipend of \$2,268.00 is 6% of Step 2 of the current RHTA Agreement. Employment shall be effective through the end of the 2014-2015 sports season unless terminated sooner. Motion carried.

Mr. Waters moved, seconded by Mr. Bragg, upon the recommendation of the Superintendent, that a member of the RHTA is allowed additional paid sick leave per Article XII of the current agreement between the Teachers' Association and the District.

Mrs. Hoerner moved, seconded by Mr. Bond, upon the recommendation of the Superintendent, that Jessica Annable, who has Initial certification in Early Childhood (B-2) and Childhood (1-6) Education, is appointed to the position of long-term substitute elementary education teacher effective April 23 through June 26, 2014.
