PERSONNEL ITEMS

Mr. Koch moved, seconded by Mrs. Hoerner, upon the recommendation of the Superintendent, that the resignation from Emma Dewart from her position as girls varsity soccer coach be accepted effective July 10, 2014.

Mr. Koch moved, seconded by Mr. Bond, upon the recommendation of the Superintendent, that the 2013-2014 APPR implementation and certification statement is approved and the Superintendent and the Board President is authorized to sign the same.

Motion carried.

Mrs. Fry moved, seconded by Mr. Koch, upon the recommendation of the Superintendent, that Rich Jennings is appointed to the position of girls varsity soccer coach for the for the 2014 sports season. Salary stipend of \$2,620.00 is 7% of Step 1 of the current RHTA Agreement. Employment shall be effective through the end of the 2014 fall sports season unless terminated sooner. 3 yes/3 no (Bond, Bragg, Riegle)

Mr. Bond moved, seconded by Mrs. Hoerner, upon the recommendation of the Superintendent, that the rate of pay for substitute RNs is established as \$20/hour for 2014-2015 school year. Motion carried.

Mr. Koch moved, seconded by Mrs. Hoerner, upon the recommendation of the Superintendent, to adopt the following:

WHEREAS, the District participates in the federally assisted national School Lunch Program and School Breakfast Program, and

WHEREAS, the District must officially and annually adopt a statement setting forth the conditions that must be followed for the District to maintain participation in the aforementioned program, therefore be it

RESOLVED, that the Board of Education, upon the recommendation of the Superintendent, adopt the attached policy statement for its National School Lunch and Breakfast Programs for the 2014-15 fiscal year, and authorize the Superintendent of Schools to sign the Certificate of Acceptance indicating the District's acceptance of same.

Mr. Koch moved, seconded by Mr. Bond, upon the recommendation of the Superintendent, that the 2014-15 contract extension for school food service management is approved and the Board President is authorized to sign the same. This is the third year of a five-year agreement; the increase is 1.9 percent (May 2014 Consumer Price Index increase) per the terms of the original agreement.

Mr. Bond moved, seconded by Mrs. Hoerner, upon the recommendation of the Superintendent, that the meal prices for the 2014-2015 school year be increased as follows:
