Mr. Koch moved, seconded by Mr. Bond, upon the recommendation of the Superintendent, that the financial statements for the fiscal year ending June 30, 2014, as prepared by Lumsden & McCormick, LLP, and as recommended by the Audit Committee, be accepted.

Mr. Waters moved, seconded by Mr. Bond, upon the recommendation of the Superintendent, that the donation of \$250.00 from the Holocaust Resource Center of Buffalo with the request that it be used to purchase Holocaust books for the high school media center be gratefully accepted. This donation has been given to the school in honor of Emily Faltyn, a senior at Royalton-Hartland, who won the Best-of-Show award in the 2013 Arts and Writing Contest.

Mrs. Fry moved, seconded by Mrs. Hoerner, upon the recommendation of the Superintendent, that the donation of the book *The Invisible Boy* by Trudy Ludwig from Lorna Seib and family be gratefully accepted.

POLICY

The Board conducted its first reading of revisions to Policy #7210 Student Evaluation.

BOARD ITEMS

Mr. Koch reported that if the wireless project includes the BOCES wing, it would be a change order of \$21,000+. The Board discussed authorizing the Superintendent to approve change orders, up to a dollar threshold, in advance of formal Board approval. The customary threshold for change orders is \$10,000. Dr. Klatt will talk to Dr. Godshall, O/N BOCES District Superintendent, to review the need for wireless access in the BOCES wing. The Board gave permission to move forward with the remainder of the project.

Mr. Koch also asked that a thank you letter be sent to the staff members who were responsible for initiating the RamPage at the start of last school year.

Mrs. Fry asked can the Roy-Hart and Barker cheerleaders be combined into one team – with both teams at the football games it gives the appearance that they are competing against each other. Mrs. Fry also asked about initiating a Pass to Play policy similar to Barker's. Mrs. Riegle stated that the Board could look at the current eligibility policy. Mr. Koch stated that Roy-Hart does not have the administrative structure to support it.

Mrs. Fry inquired as to whether there would be a Homecoming parade this year? Mr. Bell, High School Principal, stated that he has contacted all groups but was having difficulty getting staff members (adults) involved. Mrs. Fry offered to plan it for next year if no one else comes forward before next year.

SUPERINTENDENT INFORMATION/REPORTS

Per a request from Mr. Waters, the Superintendent reported that a meeting has been scheduled to discuss what evidence the District has to determine the level of benefit to students' social, emotional, and academic needs/progress at the middle school. He reported that the Administrators from both Barker and Roy-Hart met to discuss the common Superintendent's Day on October 24. He thanked Gary Bell, High School Principal, and John Fisgus, Middle School Principal for their work on the initial revisions to the Student Dress Code.
