PERSONNEL ITEMS

Mr. Owen moved, seconded by Mrs. Blumrick, upon the recommendation of the Superintendent, that Andrew Fletcher is approved as an intern effective July 1-August 31, 2017. Mr. Fletcher will be under the supervision of Mr. John Grzymala, Athletic Director.

Motion carried.

Mr. Owen moved, seconded by Mrs. Blumrick, upon the recommendation of the Superintendent, that Amanda Kast who has professional certification in the Early Childhood Education (Birth-Grade 2) and Childhood Education (Grades 1-6) certification areas is appointed to a four-year probationary teaching position in the tenure area of Elementary Education. This appointment is effective September 1, 2017 through August 31, 2021 unless extended in accordance with the law. Ms. Kast's salary of \$39,800.00 is based on Step 1 of the current RHTA Agreement. Eligibility for tenure at the end of the probationary period shall be contingent on Ms. Kast's attainment of a composite or overall Annual Professional Performance Review (APPR) rating of either "effective" or "highly effective" in three (3) of the preceding four (4) years. Additionally, if Ms. Kast receives a composite or overall annual APPR rating of "ineffective" in the final year of the probationary period, then she shall not be eligible for tenure at that time. Motion carried.

Mr. Owen moved, seconded by Mrs. Blumrick, upon the recommendation of the Superintendent, that Stephanie Lee who has initial certification in the Literacy (Birth-Grade 6) certification area is appointed to a four-year probationary teaching position in the tenure area of Reading. This appointment is effective September 1, 2017 through August 31, 2021 unless extended in accordance with the law. Ms. Lee's salary of \$39,800.00 is based on Step 1 of the current RHTA Agreement.

Eligibility for tenure at the end of the probationary period shall be contingent on Ms. Lee's attainment of a composite or overall Annual Professional Performance Review (APPR) rating of either "effective" or "highly effective" in three (3) of the preceding four (4) years. Additionally, if Ms. Lee receives a composite or overall annual APPR rating of "ineffective" in the final year of the probationary period, then she shall not be eligible for tenure at that time. Motion carried.

Mr. Owen moved, seconded by Mrs. Blumrick, upon the recommendation of the Superintendent, that Alexandra Toenniessen who has professional certification in the English Language Arts certification area is appointed to a four-year probationary teaching position in the tenure area of English. This appointment is effective September 1, 2017 through August 31, 2021 unless extended in accordance with the law. Ms. Toenniessen's salary of \$41,294.00 is based on Step 3 of the current RHTA Agreement. Eligibility for tenure at the end of the probationary period shall be contingent on Ms. Toenniessen's attainment of a composite or overall Annual Professional Performance Review (APPR) rating of either "effective" or "highly effective" in three (3) of the preceding four (4) years. Additionally, if Ms. Toenniessen receives a composite or overall annual APPR rating of "ineffective" in the final year of the probationary period, then she shall not be eligible for tenure at that time.

Motion carried.

Mr. Owen moved, seconded by Mrs. Blumrick, upon the recommendation of the Superintendent, that Kathy Beiler-Dick is appointed to a .5 FTE music teaching position. Ms. Bleiler-Dick's salary of \$40,192.00, pro-rated, is based on Step 2 of the current RHTA Agreement. Motion carried.
